### **Goods and Services VENDOR APPLICATION**

The **Rock'n Corn Festival** will be held in beautiful and historic Hatten Park, New London, WI. Set-up is on grass. We will be in Hatten Park yet, and moving to a larger location this year. Hatten Park will be closed to vehicular traffic for the festival which makes it easy for buyers to walk the grounds and for you to load and unload.

- **DATE:** Saturday, Aug. 10<sup>h</sup>, 10:00 am to 10:00pm,
- **VENDING TIME:** We ask vendors to be open as long as possible, but understand if you have more than one event scheduled that day. Please let us know and we will work with you. Vendors are not expected to stay for the entire duration of the event.
- **Set Up:** Beginning at 7:00 am- 9:30 am. Please be ready for event opening at 10:00 AM
- **PLACE:** Hatten Park New London, WI 801 Werner Allen Blvd.
- **SPACE:** 11'x 11'. Unload in front of your space – parking to be determined. Vendors do get designated VIP parking.
- **FEE:** \$35 per 11 x 11 section – Check made out to “Traumatic Brain Injury Fight for Life Team”. If needing more than one section, please notify your coordinator- **Kevin (920) 450-1308 or April (920) 250-2009**

**DEPOSIT/CANCELLATION POLICY: Full payment of \$35.00 per space is due with this application.**

Cancellation: If canceled before May1, \$15.00 will be refunded. After May 1, no refund and forfeit.

**PARTICIPATION REQUIREMENTS: You must submit a description of what you will sell and a website or Facebook page (if you have one).** You may or may not be accepted depending on the redundancy and appropriateness of your products to the festival. If you are not accepted, your check will be returned to you. We aim to limit the number of booths with similar product types to help our vendors be successful through unique offerings.

5. Do not use anything that will damage the grounds. You are liable if your tent or merchandise damages the property of others.
6. All exhibitors are responsible for insurance, licensing as well as collecting and paying state and county taxes.
7. If you arrive late or leave early without permission from the sponsor before the start of the event, you will not be allowed to return to Rock'n Corn Festival
8. Beverage sales by vendors are limited to specialty drinks only. Traumatic Brain Injury Fight for Life Team will be selling beer, wine, soda and water. Vendors are not authorized to sell beer, wine, soda or water.
